3. Each applicant may share his table(s) with one (1) additional independent dealer. The applicant assumes all responsibility, financial or otherwise, for all transactions conducted by such independent dealer and any/or other persons behind his table and recognizes By signing this application that other has the right to rely on this representation.
4. A-1 Party Rentals will not be responsible for any losses, theft, or damage, which occurs before, during, or after the dealer's Participation in the show. Dealers are solely responsible for providing their own insurance.
5. Applications may be cancelled in writing, and payment will be refunded at any time prior to December 1st, 2016.
6. Tables not claimed by 10am on Sunday, before the show, may be reassigned without refund to the table holder.
7. Radios and/or TV's are not permitted in the show area. A-1 Party Rentals reserves the right to prohibit any items from the show area that it deems inappropriate. The decision of the Show Chairman will be final.
8. The show area is a non-smoking facility. Smoking will be allowed only outside of the Pitser-Garrison Civic Center.
9. Set up time is **1-4pm – Saturday, Jan 7th, 2017 & 8-11am – Sunday, Jan 8th, 2017** for a walk-through inspection.
10. Show time **12 noon – 4pm Jan 08, 2017**. Applicant dealers or any of their agents or employees will have one hour after the close of the show on Sunday to remove all of their belongings.
